### **For what purposes do we use your personal data?**

### **Why is the treatment we carry out legitimate?**

The processing of personal data carried out by the Data Controller is legitimate within the meaning of Article 6(1)(a) since it is based on the mere interest in consultation, expressed during the website browsing experience.

### **How does it process your personal data and how long does it keep them?**

Your personal data are processed both on paper and electronically (servers, cloud databases, application software, etc.).

### To whom do we disclose personal data?

Employees and collaborators of Alosys Communication S.r.l who need to access personal data in order to provide the requested services and only for the information instrumental and connected thereto may do so. In particular:

- administrative staff;
- sales department personnel;
- production and order management office personnel.
- marketing operations personnel.

The founding element that is also reflected in the code of ethics is the absolute confidentiality of personal data processing, maintained by employees and collaborators, who are promptly informed and trained: indeed, Alosys Communication S.r.l takes all the necessary preparatory actions to draw their attention to their responsibilities in terms of personal data protection.

### Communication to third parties

The data will not be disseminated. They will be processed with providers of technological, IT and consulting services who, as a rule, act as data processors. These may also include group companies that provide services to the data controller. It is understood that data will be processed in compliance with the principle of minimisation, preferring, where possible, anonymous or anonymised data.

In particular, the categories of subjects may be as follows:

Your right to object to the processing of your personal data for commercial purposes: you may request that Alosys Communication S.r.l cease sending commercial communications at any time;

- personal data must be erased in order to comply with a legal obligation.

Right to restriction of processing: you have the right to request that Alosys Communication S.r.l restrict the processing of your personal data;

Right to data portability: you have the right to obtain a copy of your data in a structured and computer-transferable format to another data controller.
